3. Action Agenda

1. Old business

- 1. Security cameras
 - 1. Quote received from Martin Security (they provide our alarm system) for \$3360 includes 8 hi-def cameras, 3 outside, 3 in shelter, 2 in the gift shop
 - 2. Debate on whether the board feels this is something that is needed; respect for our property and security of the staff and of our things are a big concern routine thefts over the years has been of constant discussion and concern. Also concerned about cats that are getting dumped off and being able to track them
 - 3. Another possibility is to have medicators work in pairs in the evening will they be able to come in for only a couple of hours, however?
 - 4. Still trouble with medicators not locking medication cabinets suggested that repercussions will be had if they are not locked; board to write a letter
 - 5. Biggest concern is cost will wait to get Treasurer's take on costs and get a second quote
 - 6. Could the money for this come from building fund?
 - 7. Return in a month to take a vote
- 2. PNC internship completion and update on summer intern
 - 1. Alicia has finished her internship in the English program; has developed some great stuff including foster care manual, grants work, letters, website work thanks Alicia!
 - 2. Micaela will be our new intern (from Psychology) in summer will be working on an employee and volunteer wellness program; also suggested to work on a psychological profile of the typical adopter and what they need and how we could meet their needs
- 3. Building committee update

- 1. Visited TreeHouse in Chicago brought back some information about some of the things this shelter does; working on limiting their population and increasing adoptions, had 342 adoptions to date; strong public relations, has a great idea of having a "number flip" and photo op every time a cat gets adoptions
- 2. Another idea is to collect stories and share with others about adoptions successes
- 3. TreeHouse noted that they reduced their population by 2/3 and increased adoptions four-fold allowed for adopters to work with them, staff to work with them, health to be monitored easier, less vet bills, easier on volunteers and staff to clean and care for them
- 4. Had a volunteer appreciation "board" and event
- 5. Cleaned boxes 2x daily
- 6. Committee feels they are ready to take the next step to get visuals of options for new building designs; will work on basic planning

- 1. Judy provided an updated ASN voucher form; vet sets the price, time limit of 90 days has been added, other legal information not necessary for owned cats has been removed
