Dr. Regis turns grey skies blue

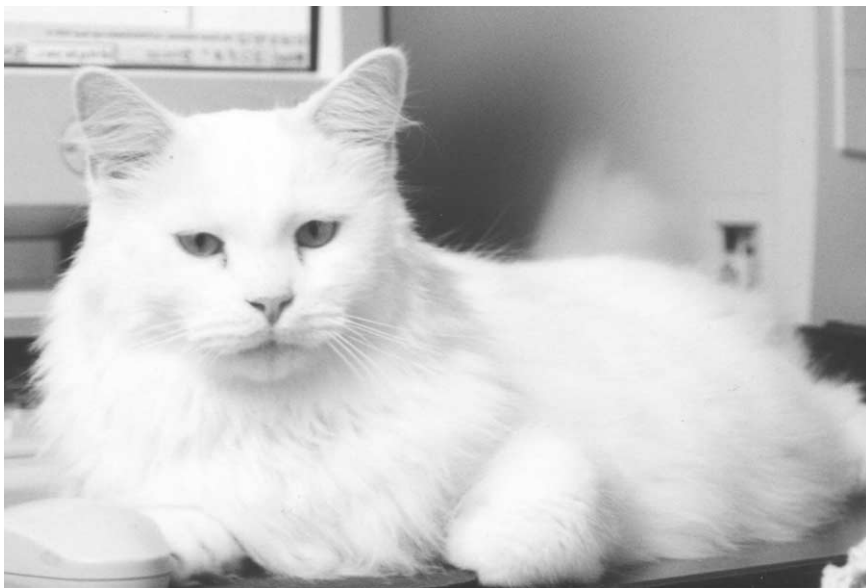
He came to the Independent Cat Society a dirty, starving stray. How were we to know then that Regis would someday change lives -- as a therapy pet?

Every Thursday, Regis, a seven-year-old with fluffy, long white fur, catches a ride from the shelter to "work," with his colleague, psychologist Cate Amador, Psy. D. Regis travels with Amador to her Valparaiso office, where he helps her clients during their therapy sessions.

Regis's job, according to Amador, is to roll around adoringly at her clients' feet. Allowing clients to pet, brush and play with him is also in his job description. Amador says it's easy to see that Regis loves his job of giving and receiving love.

"Regis's job is to give unconditional positive regard," says Amador. Amador says he helps clients feel accepted and loved for who they are without any strings attached.

Early this year, after researching cats as therapy pets, Amador discussed her idea of using a shelter cat in therapy with Independent Cat Society board members. They sug-

Between clients, Regis sits peacefully in the big office window and watches chipmunks scurry around the tall shade trees. He eats lunch with Amador and lounges on a thick, faux sheep's wool blanket that Amador lays out just for him.

During the day, Regis helps Amador stay focused on important tasks, and keeps him motivated by giving him plenty of attention and tasty treats. At the end of the day, when Amador turns off her computer, Regis cleverly hides beneath her desk in hopes of being overlooked so he can stay longer.

When Regis returns to the shelter that evening, he is always relaxed and content. The sparkle in his eyes and

gested Regis, who has a very docile, yet playful, personality.

Regis was a success after just his first day of work. Clients and co-workers benefit from his presence. His talents include calming clients during psychological testing, curing cat phobias in children, and promoting a peaceful environment for Amador's adolescent clients.

"Cats help teach social skills better than dogs," Amador says. "Dogs will tolerate loud and active behavior, but interacting with cats requires quietness and respect.

"I'd like to see more cats used in therapy since they promote feelings of acceptance, confidence and love," said Amador.

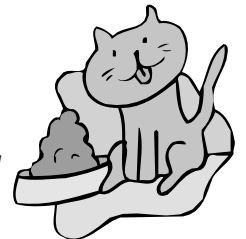

President's Message

I tried to think of a nice way to say this, a way that would persuade you, our friends and supporters. But I can't make it "sound nice." The plain fact is that we need money.

It probably seems like we always need money. We do. Operating a no-kill shelter is always financially precarious. Operating the Independent Cat Society costs roughly \$350 per day. So, it is never easy, and we are never doing well financially.

To assure you, we save money every way that we can. We've trained our staff to perform some medical testing and to give vaccines and medications at the shelter. Members of our board are not paid, and we do not have a paid administrative staff. In fact, our only paid staff are our dedicated part-time cleaning and medicating employees, who frequently clock out and finish their jobs as volunteers because they know we don't have a lot of money. We're careful about the telephone calls we make, and we wear long underwear in the winter and dress lightly in the summer to keep our energy costs low. We do everything that you do at your home to make our cats' home run most efficiently.

However, we cannot change the fact that time marches on. Many of our cats are growing older and have geriatric medical problems, which cost a great deal of money to treat. When a cat is ill, we don't automatically euthanize him or her, because we, and our benefactors, are committed to our no-kill policy.

This time of year is especially financially dismal because so many cats and kittens found their way to our door this summer. As you know, we often cannot accept cats and kittens because we seldom have room. We do not have an "open admission" policy. Because of our no-kill mission, we do not euthanize cats to make room for newcomers.

On the other hand, our county shelters must accept all animals. Of course, these shelters are full, too, and so, their courageous staff members are forced to euthanize animals to make room for new ones. As a society, we have not yet accepted that each one of us is responsible for homeless animals. Euthanasia continues because so many people, right here in our

communities, do not take responsibility for spaying and neutering every pet cat, barn cat, and stray cat that crosses their path — cats in whom they invest time, effort and expense to feed and shelter. It's simple — if a cat is not neutered, it will produce more cats, several times a year. This is the reason we, and our county shelters, are full. This is the reason euthanasia of healthy animals continues.

Although overpopulation causes us financial problems, the Independent Cat Society has never been one to "cry wolf." We try not to say that if we don't get the needed funds, we will close. But in reality, this is always a looming possibility — especially now, when we owe our vets and creditors more than \$25,000. And, we worry about what will happen to all our shelter cats if we have to close. We know we could not find homes for even half of them.

In 2005, we plan to initiate an endowment fund. We hope many of you will be interested in contributing to this fund. But first, we need to pull ourselves up by the bootstraps and find our way out of our current debt.

So please, send us what you can. It's a simple plea. We really need your help right now.

Anna's Day at the Neuter Scooter

The cute little tabby with the jaunty walk continues to bring interesting situations into my life.

The last issue of the Mewsletter described my finding Anna one year ago. My other felines, Sweetie and Art, were just at the point of an uneasy truce with each other. So, I tried to find Anna a home where her exuberance for life would have less impact on the other inhabitants.

This was not to be. And, Anna's endearing personality deeply touched my heart, so, I decided to keep her. But, by this time, unfortunately, Anna was in heat. Now, something needed to be done quickly.

Many veterinarians will not spay while the cat is in heat. Fortunately, the Neuter Scooter was coming to Michigan City.

The 80 slots for spaying/neutering filled up quickly. The Neuter Scooter people told me to bring Anna, with a clean towel or blanket, to the Michiana Humane Society, where the Neuter Scooter would be parked, at 9:00 a.m.

Pulling into the parking lot, I was surprised to see many other people standing around. The Neuter Scooter works efficiently by having everyone complete forms and drop off their cats at the same time. I gave a final look into the carrier at Anna and left.

At 8:30 p.m., I pulled back into the parking lot. Inside the

shelter, we walked along, looking for our carriers, which were lined up by number, along a wall in the humane society. Anna was number four, so I found her quickly. Peering into the carrier, I was amazed to find a transformed Anna.

Her eyes were wide. A strange, guttural sound I had not heard before came from her throat. The change in hormones from the loving, sweet feline in heat to what was going on in her body now was unbelievable. It took her awhile at home to calm down, but she was fine by the next morning.

The Neuter Scooter is a wonderful way for shelters and communities to control pet and feral cat overpopulation. The mobile spay/neuter clinic travels around Indiana and Ohio. Organizations and individuals contact the Neuter Scooter to host a day.

As you bring a new cat into your own home or work to diminish the number of stray and feral cats in your community, the Neuter Scooter will be available to augment local veterinary care. May your experience be as meaningful as it was to those of us gathered in the parking lot that day, knowing we were doing the right thing by spaying/neutering the felines in our homes and neighborhoods.

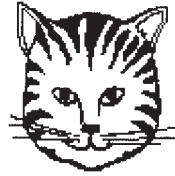
bounce in his step tells us he's had a good time.
